

“Information on personal data processing in accordance with the GDPR”

On the basis of the applicable provisions of law on personal data protection, in particular the General Regulation, in order to ensure adequate protection of personal data, the data subject should, in particular, be provided with the information on the processing of the personal data referred to in Articles 13 and 14(1) and (2) of the GDPR, depending on whether it was obtained directly from the data subject or from other sources.

Taking the above-mentioned into consideration, TT PLAST S.A. hereby informs you that:

1. The Data Controller of your personal data is:

3. Your personal data is processed on the basis of Article 6(1)(B) of the GDPR, i.e. for the purpose of execution of trade and marketing cooperation agreements;
4. We hereby inform you that the consequence of refusing to provide your personal data will be the lack of possibility to perform cooperation agreements.
5. Your personal data is processed manually and automatically without profiling;
6. The Data Controller processes your personal data to the extent that it is made available by you and available from public sources, i.e. from the Register of Entrepreneurs of the National Court Register (KRS), Central Registration and Information on Business (CEiDG).
7. The personal data may be made available to entities cooperating with TT PLAST and outsourcing companies for the purposes necessary for the execution of concluded agreements and the fulfilment of obligations arising from the provisions of law;
8. Your personal data will not be transferred to a third country/international organisation.
9. The Data Controller uses its best endeavours that the personal data stored are physically, technically and organisationally protected against accidental or deliberate destruction, accidental loss, alteration, unauthorised disclosure, use or access, in accordance with all applicable legal provisions;
10. The personal data shall be stored for six years.
In connection with the processing of your personal data, you have the right to:
 - request access to your personal data from the Data Controller,
 - request correction of your personal data from the Data Controller,
 - require the Data Controller to erase your personal data,
 - require the Data Controller to restrict the processing of your personal data,
 - object to the processing of your personal data,
 - transfer your personal data
 - lodge a complaint with a supervisory authority;The aforementioned rights and restrictions on their exercising are set out in the provisions of Articles 15-21 of the GDPR.
